Keep track of payments by payers and the percentages of payments to charges, as this can be used in appeal letters to establish a precedent for additional payment (i.e. Blue Cross's "YLK" Plan paid 80 percent of charges for patients Smith, Jones and Mann, thus they should pay 80 percent of charges for the appealed claims).

What to include in your letter In your appeal letter, be sure to include the claim number, patient name and ID number, the date of service, and the amount billed. Begin the body of the letter by outlining your expectations for claim settlement. Then explain why the claim should pay per the expectations you describe.

How to Write an Appeal Letter

1 A corrected claim must be submitted within the timely filing period for claims. A corrected claim is not a claim appeal and does not alter or toll the deadline for submitting an appeal on any given claim. 2 A claim reconsideration request is not a claim appeal and does not alter or toll the deadline for submitting an appeal on any given claim.

Single Paper Claim Reconsideration Request Form

An appeal to the insurer may be required by the state as a precondition to later appealing to, or lodging complaints with state regulatory agencies. The validity of your appeal may also enhance your chances of recovering underpayment in court if that avenue becomes necessary.

ACEP // Appealing Denied Claims FAQ

If your insurance provider denies payment for a medical procedure, you will need to write a letter to appeal the decision. The Affordable Care Act increased patients' rights regarding appeals. Insurance companies are now required to explain the exact reasons they denied your claim. They must also allow you six months to appeal.

Appeal Letter to Insurance Company Writing Tips. The letter must be written formally. All the valid documents must be provided along with the letter. Facts, figures should be presented logically. There must be a positive undertone to the letter. The contact details of the writer should be provided.
