"Old comparative corporate governance" refers to the dichotomy between dispersed and concentrated ownership studied by scholars of comparative corporate governance throughout much of the second half of the 20 th Century. US corporate governance was characterized by management-oriented corporate law, dispersed ownership originally with a relatively large share held by retail investors, and collective action problems that inhibited shareholder coordination and thus influence on management.
